Dear Governor Pritzker:

Pursuant to 40 ILCS 5/1A-108.5, the Illinois Police Officers' Pension Investment Fund (IPOPIF) recognizes that it is the public policy of the State of Illinois to promote the economy of Illinois through the use of economic opportunity investments to the greatest extent feasible within the bounds of financial and fiduciary prudence. Accordingly, IPOPIF submits the following disclosures of IPOPIF investment holdings:

1. Exhibit 1: Publicly traded equity securities headquartered in Illinois.
2. Exhibit 2: Publicly traded fixed income securities issued by firms headquartered in Illinois.
3. Exhibit 3: Private real estate properties located in Illinois that are held within an open-ended commingled fund.

IPOPIF was created by Illinois Public Act 101-0610 to consolidate the 357 Article 3 local downstate and suburban Chicago police pension funds and began asset consolidation transfers in March 2022. Through June 30, 2024, 333 funds had transferred investment assets to IPOPIF. The remaining fund consolidation transition is scheduled for October 2024.

The disclosures were compiled based on assets held as of June 30, 2024, with the total value of \$10.5 billion.

During 2024, the IPOPIF Board began transitioning the portfolio to the long-term asset allocation and approved their first active international small cap equity strategies managed by Acadian Asset Management, Boston, MA, LSV Asset Management, Chicago, IL, and WCM Investment Management, Laguna Beach, CA. Subsequently, the IPOPIF Board also approved their first bank loans strategies managed by Ares Management and Aristotle Pacific Capital, both based out of Los Angeles, CA. The Board also approved RFPs in Emerging Markets Debt, Emerging Markets Equity ex China, and Private Credit.

The IPOPIF Board, to the greatest extent feasible within the bounds of financial and fiduciary prudence, has and will continue to consider economic opportunity investments within the State of Illinois.
