Mr. Jordan noted that he used to work for the City of Chicago, and he is concerned with the future of his pension due to the funding status of the pension fund. He thanked the Trustees for their hard work on the Board and stressed the importance of considering and selecting a general investment consultant. He requested that the Board of Trustees select a firm with a track record of strong investment performance and a firm that has years of experience with pension funds that can outperform their benchmarks. Committee Chairperson Suess thanked Mr. Jordan for his comment to the Committee.
