Executive Director White prepared a Request for Quotes for human resources providers that was published on January 27, 2021 with a due date to respond by February 3, 2021. Executive Director White informed the Board that the Fund received one response from Lauterbach & Amen, LLP and their proposal was provided to the Trustees for review. The proposed hourly fee arrangement is as follows: a recruiting fee of \$75 per hour for a Specialist and \$125 per hour for a Director; and a consulting fee of \$100 per hour for a Specialist and \$175 per hour for a Director.
