### **NAV and Receivable Calculations Under Development**

- The IPOPIF <u>Valuation and Cost Rule</u>, AR-2022-01, stipulates that the Net Asset Value (NAV) for each Participating Police Pension Fund will include a proportionate share of the IFA Loan and also receivables representing proportionate amounts due from late-transferring pension funds.
- These calculations are still under development.

## **February Highlights**

- The IPOPIF Pool (the main investment fund) declined 2.22% in February.
- Asset Flows
  - New Asset Transfers: \$24 million
  - o Cash Contributions: \$72 million
  - o Cash Withdrawals: \$23 million
- Total Fund ending value: \$8.858 billion
  - o IPOPIF Pool: \$8.839 billion
  - o Transition Pool \$16.8 million
  - o Participant accounts: \$2.1 million

- Expenses
  - Administrative Expenses: \$198,410
  - Non-manager Investment Expenses: \$163,187
  - o Investment Manager Fees \$13,699
  - o Expenses are paid from the IPOPIF Pool
